

TEMPORARY CLOSURE OF VARIOUS FOOTPATHS FOR
WYEDEAN STAGES MOTOR RALLY 2024
(CINDERFORD TOWN AND VARIOUS PARISHES) FOREST OF DEAN DISTRICT

NOTICE is hereby given that Gloucestershire County Council has made an Order to close temporarily under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984 (as amended) part of the footpaths as described in the Schedule below.

Schedule

**Temp Closure of Public Footpaths RWD/31 & RWD/45, West Dean
(As shown on Order Plan 1)**

Part of Public Footpath RWD/45 at West Dean from its junction with Public Footpath RWD 48 at OSGR SO 6223/1183 (Point A on the Order Plan 1) and running in a generally south easterly direction for approximately 575 metres to its junction with DRP/25 at OSGR SO 6264/1149 (Point B) and shown by a solid black line A-B.

Public Footpath RWD/31 at West Dean is to be temporarily closed from its junction with DRP/30 at OSGR 6340/1020 (Point G on the Order Plan 1) and running in a generally south westerly direction for approximately 1.13 kilometres to its junction with the C18 at Moseley Green at OSGR 6286/0925 (Point H) and shown by a solid black line G - H.

**Temp Closure of Public Footpaths DRP/23, DRP/24, DRP/25 & DRP/30 Ruspidge
(As shown on Order Plan 1)**

Public Footpath DRP/23 at Ruspidge is to be temporarily closed from its junction with the B4226 at OSGR SO 6414/1255 (Point C on the Order Plan 1) and running in a generally south westerly direction for approximately 2.4 kilometres to its junction with DRP/25 at OSGR SO 6311/1110 (Point D) and shown by a solid black line C – D.

Public Footpath DRP/25 at Ruspidge is to be temporarily closed from its junction with RWD/45 at OSGR SO 6262/1149 (Point B on the Order Plan 1) and running in a generally south easterly direction for approximately 1.37 kilometres to its junction with DRP/24 at OSGR SO 6369/1063 (Point E) and shown by a solid black line B – D – E.

Public Footpath DRP/24 at Ruspidge is to be temporarily closed from its junction with DRP/25 at OSGR 6369/1063 (Point E on the Order Plan 1) and running in a generally south easterly direction for approximately 2.4 kilometres to its junction with the Class 4 road 403008 near Upper Soudley at OSGR SO 6571/0982 (Point F) and shown by a solid black line E - F.

Public Footpath DRP/30 in Ruspidge is to be temporarily closed from its junction with DRP/24 and DRP/25 at OSGR SO 6369/1063 (Point E on the Order Plan 1) and running in a generally south westerly direction for approximately 540 metres to its junction with RWD/31 at OSGR SO 6340/1020 (Point G) and shown by a solid black line E-G.

**Temp Closure of Public Footpath DCF/10, Cinderford
(As shown on Order Plan 2)**

Public Footpath DCF/10 at Cinderford, is to be temporarily closed from its junction with the A4151 at Steam Mills at OSGR SO 6452/1606 (Point A on the Order Plan 2) and running in a generally south westerly direction for approximately 3.3 kilometres to its junction with Public Footpath DCF/12 at Crabtree Hill at OSGR SO 6317/1373 (Point B) and shown by a solid black line A-B.

The footpaths fall with-in the Parishes of West Dean, Ruspidge, and Cinderford Town in the county of Gloucestershire.

The closures are necessary for the Wyedean Stages Motor Rally 2024.

The Order will come into force on the **Saturday 16th November 2024** and it is anticipated the said footpaths will close on that day only, **between the hours of 12.01 am and 11.59pm**, or whenever the said event is completed, whichever is later.

Alternative route: None

Emergency and pedestrian access to adjoining premises will be maintained.
