

TEMPORARY CLOSURE OF VARIOUS ROADS (VARIOUS PARISHES) FOREST OF DEAN DISTRICT

Gloucestershire County Council, as traffic authority, has made an Order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close and restrict part of the lengths of road as detailed in the Schedule below.

There will be no waiting and no loading permitted throughout the duration of the said works.

The said roads are expected to be closed and restricted, during various times, on a rolling programme commencing **22nd September 2025** where the presence of approved signage will

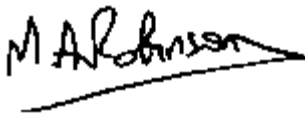
indicate whether the same are in force. Further advance warnings of dates/times will be displayed on site prior to the closures and restrictions taking effect. This Order may permit the said closures and restrictions in any order, or simultaneously as required. It is anticipated all works will be completed by **31st August 2026**.
