

TEMPORARY CLOSURE AND RESTRICTION OF VARIOUS ROADS (WEST DEAN PARISH) FOREST OF DEAN DISTRICT

Gloucestershire County Council, as traffic authority, intends to make an Order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close and restrict part of the lengths of roads as detailed in the Schedule below.

There will be no stopping or waiting and no loading permitted throughout the duration of the said works.

The said roads are expected to be closed and restricted **each night between 19:00hrs and 07:00hrs** on a rolling programme commencing **17th August 2026** where the presence of approved signage will indicate whether the said closures and restrictions are in force. Further advance warnings of dates/times will be displayed on site prior to the said closures and restrictions taking

effect. This Order may permit the said closures and restrictions in any order, or simultaneously as required. It is anticipated all works will be completed by **28th August 2026**.
