

TEMPORARY CLOSURE OF VARIOUS ROADS (VARIOUS TOWNS AND PARISHES) FOREST OF DEAN DISTRICT

The reason for the said closures is for carriageway patching works.

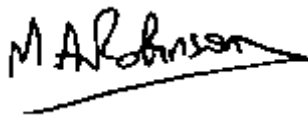

Further advance warnings of dates/times will be displayed on site prior to the said closures taking effect. This Order may permit the said closures in any order, or simultaneously as required. It is anticipated that all works will be completed by **31st March 2027**, but the Order may continue until the said works have been completed, for a maximum duration of 18 months.
